PLEDGE OF ALLEGIANCE

CALL TO ORDER: Mayor Stein called the meeting to order at 6:00 p.m.

ROLL CALL: Members present were Robert Stein, Robert Lawson, and Deborah Trboyevich.

Nancilyn Meyer and Trevor Guyer were absent with Guyer expected to arrive

shortly. All motions passed 3-0 unless noted otherwise.

PRESENT: Staff present were Jestine Casey and Alan Johnson. Also present were Devon

Doree, Troy Otterson and Michael Alton.

TRUTH AND TAXATION: Casey provided Council and the public with informational handouts. The

budget and levy were discussed and will be formally approved at the next

Council meeting.

GUESTS: Troy Otterson – Tavern on the Range utility rates. Otterson is requesting his

utility rates be adjusted appropriately from 6 units to 4 units: 2 for the bar and 1

for each apartment. He is also requesting credit for past overcharges. He advised that there used to be a full bar and apartments in the basement, but this is no longer the case. He feels he is still being charged for the basement rooms. He also advised that he has discussed this issue with city staff on previous occasions but his complaints were dismissed. Trboyevich explained that the Public Utility Board set the formula a long time ago. Mayor Stein

advised that Council just received this information and is in the process of

gathering more so this will be tabled until the next meeting.

Derek Vekich – Middle School Apartment Complex Project- Vekich was unable to attend but provided Council with a letter requesting the City be fiscal agent.

This will be put on the next agenda.

- 1. Engineer, Alan Johnson
 - a. Northern Contracting pay request & change order- \$43,046.25. There was a discussion, and it was determined that Minnesota Power initially trenched and buried the electrical wires that had to be re-trenched and re-buried to the correct depth. Doree advised that Jeremy Schwarze has pictures and documented what occurred. Motion Guyer 2nd Trboyevich to approve the pay request payment of \$43,046.25. All in favor.
 - b. Baratto Brothers pay request 2 \$37,543.05. Johnson answered questions Council had. This was tabled until the next meeting.
