GUESTS: Derek Vekich -request for city to be fiscal agent for Middle School project-

Vekich provided Council with a development agreement. Whitney from the IRRRB would like city involvement. IRRRB requires a resolution and development agreement. This will be discussed at the next workshop as Vekich needs the

agreement by January 15th.

Troy Otterson – Tavern on the Range Utility Rates & Liquor License- Odden provided Council with one page of an ordinance adopted in the 1980s that established charges for various buildings and businesses, including the bar.
